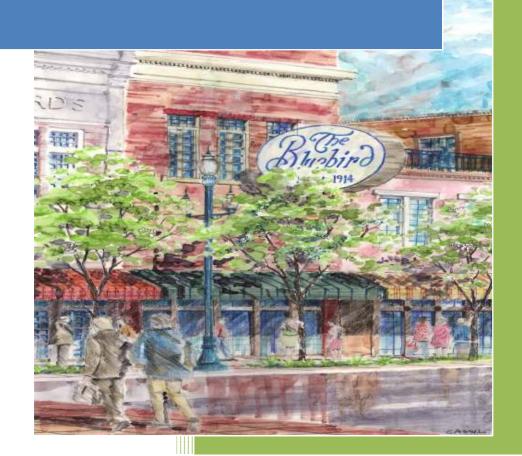

PLANNING COMMISSION

At the July 9, 2015 meeting, the Planning Commission conditionally approved a **Design Review Permit** for:

PC 15-027 GW Properties 6-plex

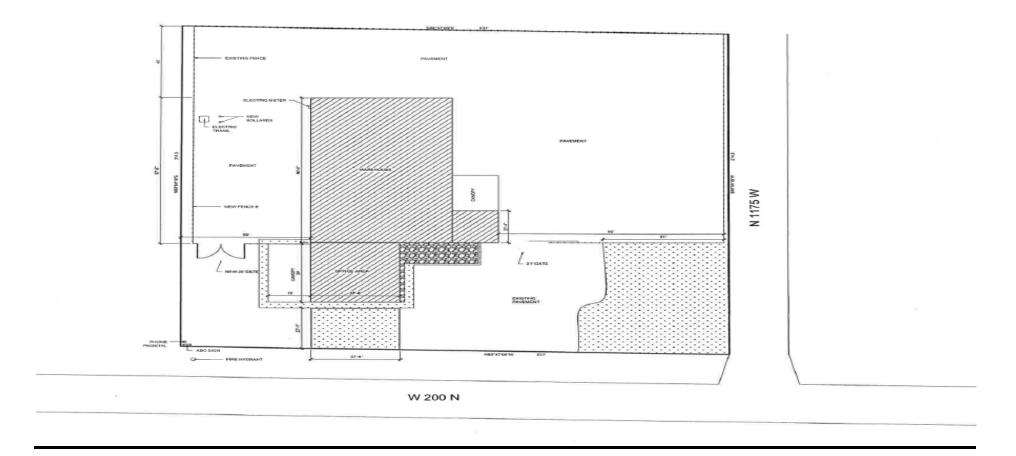
Removal of the existing structure and construction of a 3-story 6-plex on .3 acres at 274 East 300 North in the Mixed Residential (MR-20) zone; TIN 06-063-0024.



At the July 9, 2015 meeting, the Planning Commission conditionally approved a **Design Review & Conditional Use Permit** for:

PC 15-033 ABC Supply Co.

A 7,700 SF building to be used as a distribution warehouse with outdoor storage in the Commercial Services (CS) zone located 1170 West 200 North.



At the July 23, 2015 meeting, the Planning Commission continued the project to the August 27, 2015 meeting.

PC 15-034 Maverik - 1000 W.

A 5,046 SF convenience store with seven (7) gas pumps and 44 parking stalls located at 200 North 1000 West in the Commercial zone.

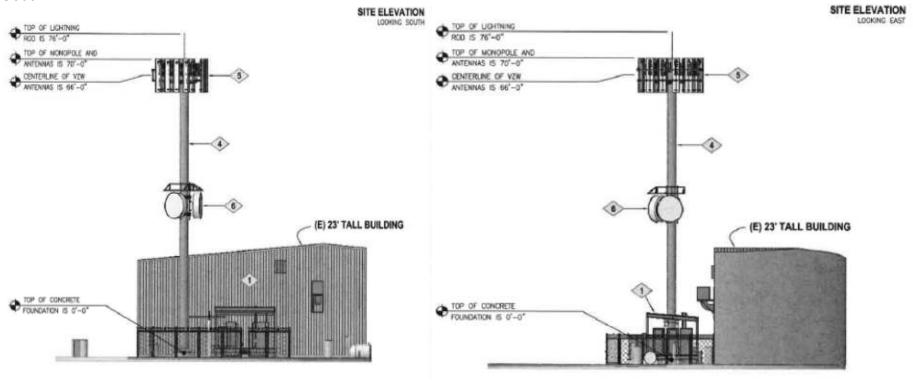




At the July 23, 2015 meeting, the Planning Commission conditionally approved a Conditional Use Permit for:

A 70' tower with a full array of antennas and two microwave dishes on 880 SF in the Industrial Park (IP) zone located at 695 West 1700 South.



PLANNING COMMISSION

PC 15-036 Logan City Bicycle & Pedestrian Master Plan

At the request of the Planning Commission, staff is preparing a three-phased presentation to break the large master plan document into smaller more manageable review sections. The first phase will focus on the vision statement, plan goals, existing policies, inventory, demographics and needs analysis. The second phase will focus on program and infrastructure design recommendations. The third phase will focus on cost and implementation.

Bicycling and walking is a healthy, inexpensive and environmentally friendly option to get around town for both recreational and transportation purposes. While Logan City already has a relatively high number of citizens that bike and walk, improvements could be made that attract even more users. National studies show that the majority of people are interested in walking and bike opportunities, but are concerned about safety and comfort levels in certain urban environments. This master plan and strategy, targets this majority group of people that are "interested but concerned" and attempts to tailor a plan that considers our unique local conditions and results in an increase of users.

Y-INTERSECTION LANDSCAPING

The "Y intersection" landscaping project is complete. This project was funded by Logan City with the intent of beautifying the entrance into Logan. The landscape design was chosen with a number of goals in mind: improve the aesthetics of this specific area, choose a variety of plants and materials that will minimize the use of water while being salt tolerant, and not create a safety hazard for motorists traveling on South Main. Are you wondering why there are not any trees or bigger rocks in these two planters? Utah State Department of Transportation (UDOT) regulations limit the height of material and the size of trees next to State highways in order to minimize potential hazards for motorists. While the plants may look a little sparse right now, by next growing season, most of the plant material will fill in and provide a very nice green space within a sea of asphalt.

The design work was completed by Logan City Community Development staff and the preliminary site work was by completed by Logan City Public Works. WAYFINDING

Phase II of the **Logan City Wayfinding Project** is currently in the design stage and will be installed this fall.

Phase I was installed earlier this year with a variety of different signs on Main Street and 4th South. The purpose of a wayfinding program is to provide a unified sign system that helps both residents and visitors navigate to different areas and locations throughout the City. The wayfinding system, through consistent color and design elements, identifies unique districts such as the University district, downtown, the theatre district, and different recreational areas. You will see new signs popping up in the downtown area as well as around the southwest part of Logan directing people towards the City's many recreational areas.



GATEWAY ENTRANCE SIGN

The first "Welcome to Logan" gateway sign is located on the South side of Highway 89/91 and welcomes motorists as they travel north into Logan City. This site was chosen due to its proximity to the Logan River Golf Course located directly across the highway and the natural open space surrounding the new sign. The sign design and colors were chosen to complement the natural open areas of the site. The site work and sign construction was completed by Logan City Parks & Recreation employees, the rock work was done by Tony G. Nielson Masonry of Logan, and the metal signage and lighting was done by Superior Sign, Inc. of Logan. Logan City Light & Power employees installed power for the sign. Final work, including the installation of irrigation and landscaping, will be completed during July & August as weather permits.
